The Superintendent reported:

- The following positions have been posted on EdJoin for the 21-22 school year: 0.4 FTE Special Education Teacher, TK-3 Primary Teacher Pool, and Superintendent/Principal/Teacher
- Jessica Noble is preparing to take the Food Manager Exam required to maintain the school kitchen
- Summer School is being planned, with morning Enrichment and afternoon
 Advancement. Expanded Learning Opportunity Grant funding will be used.
- A yearbook is being put together by teaching staff, and picture day was April 20th
- Students and staff will be tie dying t-shirts for Field Day
- Tacky Day is being planned for June 9th
- B. Enrollment
- California Dept. of Public Health is anticipating schools can offer full in-person instruction to all students next school year. Staff are reaching out to current families about returning and getting inquiries about interdistrict transfers for 21-22.

- C. Curriculum and Instruction
- Staff participated in a informational webinar about Discovery Education's NGSS science curriculum.
- The last E3 meeting was on April 16th, with teaching standards the topic of discussion.
- D. Facility Update
- The pergola and wisteria were removed. The roof needs repair and the dormer needs clearing.
