A. Superintendent/Principal Report

The Superintendent reported:

- Assessments are being completed as the school year comes to an end.
- The Summer Program will focus on Art/Gardening/PE for all and will include targeted Instruction for students identified as benefiting from such instruction.
- B. Enrollment
- Total enrollment will be similar next year, but it appears the students will be younger.
- C. Curriculum and Instruction
- Science curriculum review continues.
- D. Facility Update
- Annex roof including insulation has been installed. The slab will be poured on Wednesday May 26, and the Caltrans permit for taking electrical lines under the road is in process.
- The fridge in the kitchen needs servicing.
- The Hobart sanitizer has needed service several times, and is now under a service contract.
- E. Business Report

- The 20-21 audit has started, with a focus on attendance, and the auditor looking at other info that is typically provided in the fall.
- The Governor's May Budget Revision was presented on May 14th. The economic outlook is positive.

IV. INFORMATION AND STUDY

A. Preschool Update

The Interim Superintendent reported to the Board details about licensing and funding the preschool. In summary, the preschool will need to be licensed to serve both preschoolers and toddlers. Licensing involves designating a signatory, likely the new superintendent, who will complete the licensing training and guide the district through the process. This process will need to be started ASAP. Teachers and staff will need to complete varying early childhood development courses, and proper ratios must be maintained. Regarding funding, there are several options, with a Fee for Service program offering the most flexibility. This option allows for morning, afternoon, and full day options. Parents that qualify based on need can get vouchers from the state. A summer kinder camp for 4 year olds is a possibility for kids entering Kindergarten in the fall.

B. Job Openings Candidate Summary

Job postings on Edjoin for a Superintendent/Principal/Teacher, a 0.4 FTE Special Education Teacher and a Primary Teacher Pool closed on May 18th. The Interim Superintendent is reviewing the candidate's submissions.

C. MTSS Handbook

Spencer Valley is part of a grant consortium through SDCOE. The MTSS handbook describes how the district meets the needs of all students (Universal Prevention, Tier 1), targeted intervention for students with some risk factors (Tier 2) and Intensive intervention for students at high risk (Tier 3).

D. Science Curriculum Adoption

Teachers have been reviewing science curriculum. The hands-on component and built-in assessments will be the focus of the review.
