## A. Approve P-Line Consulting Architectural & Engineering Services Fee Adjustment Request

**DESCRIPTION:** P-Line Consulting, Inc. is the architect for Phase 2 of the Annex project. The have requested an adjustment to their services fee based in the difference in cost between the original proposal and the actual amount. The initial contract was for 8.5% of \$3.6 million for an amount of \$306,000. The actual project costs are \$4,492,526.91. These costs include the true phase 2 construction amount of \$4.127 million and phase 2 work was completed in Phase 1 for an amount of \$365,526.91. The fee amount, at 8.5%, is \$381,864.78. **BUDGET IMPLICATIONS:** An additional \$75,864.78 from Fund 40 Reserve for Capital Projects.

## B. Approve 21-22 Second Interim Budget
