# D. Approve Services Agreement with SDCOE for COPES Initiative

**DESCRIPTION:** The Creating Opportunities in Preventing & Eliminating Suicide (COPES) Initiative, a program lead by SDCOE, serves to build capacity of local educational agencies to support school communities that champion mental wellness. The services agreement sets forth the requirements for Spencer Valley, including identifying a COPES liaison and leadership team, giving the California Healthy Kids survey, using an evidence-based suicide risk screening tool, and collecting risk screening data.

**BUDGET IMPLICATIONS:** \$12,000 per year, for 4 years, from Mental Health Student Services Act (MHSSA) grant.
