The Principal reported:

- Don Winslow will talk to the RH students about Shakespeare on January 13th.

B. Superintendent/Principal Report

The Superintendent reported:

- A parent governance team is being assembled for this year's committees; requests for more parents to attend have been successful. The committees will meet in the immediate future. Site Plan and LCAP Goals are being reexamined.
- Mid-year testing results are being used to determine the most effective use of Spencer Valley's Special Education specialist's time.

C. Enrollment

- One student moved out of state. Enrollment is currently 31 students.
- Chronic absentee letters will be sent out.

- RH Teachers will attend Next Generation Science workshop to learn to integrate common core literacy approaches with Next Generation Science standards on January 19.

E. Facility Update

The Superintendent reported:

- Partial water testing results were received; additional different tests are being conducted.
- Lights in the OSH are being repaired.
- The trim in the courtyard and the doors need painting.
- The roof leaked through the cupola in the OSH. It is being monitored to see if the wind caused the issue or if there is a roof breach.
