PROPOSAL: To approve the MOA with the San Joaquin County Office of Education. **BACKGROUND:** The San Joaquin County Office of Education (SJCOE) Center for Educational Development and Research (CEDR) has developed and maintains the Special Education Information System (SEIS) that is used for online management of IEPs and Special Education records. The Student Information System (SIS) is used to track student data such as daily attendance. The CEDR is working on setup/configuration and support of integration components and services to allow data transfer between SEIS and SIS.

BUDGET IMPLICATIONS: \$0.75 per student based on the current district special education student count as of December 1 CASEMIS report. Current maintenance fee is \$208.50 based on CASEMIS count of 278 students.
