- III. PUBLIC COMMUNICATION: None.

#### IV. REPORT SECTION – Oral

A. Staff Sharing

The Superintendent shared:

- The Wolf Education Project visited Spencer Valley with 2 animal ambassadors and presented a program to all students on wolf ecology and behavior.
- Valentine's Day events are planned in correlation with the Great Kindness Challenge.
- A request has been made to take a field trip to the capital for the 5<sup>th</sup> and 7<sup>th</sup> graders.
- Interim report cards were sent home for parents to be able to understand progress made on students that may need assistance.
- NWEA testing is being completed in all grades.
- B. Superintendent/Principal Report The Superintendent reported:

- A grant has been awarded to the SELPA add a Special Education intern teacher. The Superintendents in our region are collaborating to see if there will be enough funding to develop regional programs at a local site.
- Play rehearsal has begun; costumes and sets need to be completed; and a chef still needs to be confirmed.
- One new in-district pre-school aged student is being assessed.
- The SELPA is assisting with the Student Study Team process.
- LCAP Parent Advisory Committee and Site Advisory Committee meetings are scheduled for next Thursday.
- SST meetings are scheduled for students needing extra assistance.
- C. Enrollment
- Current enrollment is 43 students 23 in Old School House and 20 in Ritchie Hall. Three
   (3) ESK students started on January 16<sup>th</sup>.
- Attendance for January was 93.6%; YTD Attendance, through January, was 95.2%
- Enrollment projections for 19-20 are 19 in OSH and 26 in RH.
- D. Curriculum and Instruction
- Teachers and other staff attended Nonviolent Crisis Intervention Training. This required training provides ways to de-escalate and handle student behaviors.
- The Superintendent attended the Instructional Materials Science Fair at the County Office of Education to look at state approved science textbooks.
- The County Office of Education is providing training to teachers on Writing Rigorous Performance Tasks for students.
- The BTSA teachers observed in other districts.
- Audrey Weed from the SELPA will be supporting the SST discussion with the school psychologist and the teachers.
- Teachers who have not previously attended Best Behavior: Building Positive Behavior Interventions and Supports with Jeffrey Sprague will have the opportunity to attend in April or May.
- Social Studies Adoption will take place in 19-20.
- PIAT, a seminar series on writing the LCAP, will be attended next week.
- E. Facility Update
  - The Superintendent reported:
- The kitchen needs a new stovetop or new inserts.
- The old lawn tractor is broken and the repair cost is the same as the cost of a new machine.
- The FIT survey was completed. Required repairs and planned upgrades were noted.
- A quote was received for student bathroom remodels.
- F. Business Report
  - The CBO provided:
- 18-19 P-1 ADA is 39.07 for SVS, 1936.34 for CAVA@SD and 210.03 for Insight@SD.
- The Governor released his January budget. Although the governor did not propose additional funding for schools, with the only increase in LCFF funding a cost of living adjustment, the budget does include a proposal to pay \$2.3 billion to reduce school districts' share of the CalSTRS unfunded liability.
- The County Office agreed with our positive certification for First Interim.

- Kevin Gordon of Capital Advisors, Mike Fine of FCMAT and John Grey from School Services of California provided their respective organizations perspectives on the Governor's budget at the CBO Forum.
- A handbook on the Brown Act is available for reading in the office.

#### V. INFORMATION AND STUDY

#### A. After School Homework Center

The Superintendent shared updated documents from the architects, including an overall site plan, the homework & preschool center, and possible roof elevations and design elements.

## B. PROTECT: Prevention Organized To Educate Children on Trafficking

The Superintendent shared AB1227 Human Trafficking Prevention Education and Training Act, which requires California public schools to offer education and training for grades 7-12 on human trafficking identification and prevention in order to avert children from being exploited for labor or sex. PROTECT is a program developed by the SD County District Attorney's office for SD Public Schools. PROTECT is a holistic classroom education program that provides teachers and students with a comprehensive understanding of the dangers and signs of human trafficking and exploitation. At the elementary school level, the curriculum focuses on stranger danger.

# C. Social Studies Curriculum Adoption

The Superintendent shared that the teachers had evaluated the available programs and completed a Textbook Adoption Toolkit for social studies and will be piloting selections in the spring.
