A. Staff Sharing

The Superintendent shared:

- The 5th-8th grade teacher is looking into a trip to Catalina, with SVEA covering costs.
- The first Shakespeare play read through occurred. The play, As You Like It, will be put on as a radio show.
- A LCAP PAC and SAC joint parent meeting was held on January 9th but was not well attended. The meeting will be repeated next Tuesday after school. The Shakespeare play including the dinner theater and auction will be the main topic.
- Students completed mid year NWEA testing. Most students made at least mild progress.
- Interim CAASPP testing will be completed in January.
- Teachers participating in BTSA are completing observations and projects.
- B. Superintendent/Principal Report

The Superintendent reported:

- JPA Representatives visited for their yearly check-in meeting. They recommended getting course of construction insurance and an independent playground inspection.
- Cassie Nelson has been hired as the Shakespeare play director.
- She attended Dyslexia training, required as part of a legislative change affecting recognition of dyslexia as a condition.
- CAVA@SD is eligible to receive Differentiated Assistance due to deficiencies in their graduation rate and chronic absenteeism indicators. This will require the District, CAVA & SDCOE representation to analyze the numbers and generate ideas to mitigate these circumstances.
- Two annex meetings were attended. Building specifics were discussed with Jeff Bloedorn of TLS Choice and an architect meeting took place at StudioWC to discuss the transition plan from StudioWC to P-Line.
- C. Enrollment
- Current enrollment is 45 students, with 2 ESK students starting January 21st. Two
 additional in-district students may also start on the 21st.
- D. Curriculum and Instruction
- Audrey Weed, from the SELPA, presented UDL strategies, including useful websites.
- Progress and support of each individual EL learner will be discussed in team meetings on February 25th.
- The first of three dyslexia trainings has taken place.
