B. Superintendent/Principal Report

The Superintendent reported:

- She attended an Esports training all last week. The hope would be to implement Esports during after school programming on Thursdays.
- Twenty-three (23) Jump Start Summer Camp students went on a field trip to Sesame Place last Friday with 5 adults. The students had a blast.
- She has found our director for Shakespeare, Kelly Ford. She used to live up here as a child and has recently returned. She is a theater director at a community college and volunteered to be the director to give back to the community. She is also interested in coming in and working with students on theater. We will meet with her in September or October to get the ball rolling. She has already chosen to do As You Like It and has some great ideas.

- All call will go out this Sunday to all SV families. The weekly folder and newsletters will continue to be sent home on Mondays.
- Staff first day is Monday, August 14th. On that day, Supt. Baas will be holding small group meetings with different staff members the entire day, including a lunch/recess meeting, ELOP meeting, preschool meeting, special education meeting, and intervention meeting.
- An all staff meeting will be held on Tuesday, August 15th. Breakfast and lunch will be provided that day for all staff. Agenda items include reviewing the staff binder, going over our Safety Plan, Active Shooter Training, and other items for the start of the year.
- Special Services Update MOU with SELPA. The SELPA will contract with other
 providers in order to provide the small school districts with the necessary services we
 require. Services required for 23-24 include speech & language path, psychologist, OT,
 and PT. There will be monthly meetings with the service providers at the SELPA and
 she will be the superintendent representative for these meetings.
- Back to School Night will be held on Thursday, August 31st at 6 PM.

C. Enrollment

- Forty-seven (47) students are registered.
- 22-23 school year attendance rate was 95.1%.

D. Curriculum and Instruction

- One of this year's projects will be looking at Health curriculum for 5th and 7th grades and Art curriculum for all classes.
- Music classes (Thursdays) and Spanish classes (Wednesdays) will be held for all students.
- SV is part of the COPES grant, and due to this we will be participating in SEL curriculum training for Elementary and Middle School. The Elementary Training will take place on August 28th and 29th, Shalom and Supt. Baas will be attending. A Middle School training date is not yet set, but Allyson and Pamela will attend.

E. Facility Update

Preschool licensing inspection revealed some minor clerical issues, along with a requirement to fence the pond. One of the teachers will be the site supervisor on paper, so she needs to do 2 online training sessions., the last of which is tomorrow. Supt. Baas is the administrator. Hopefully licensing can come back next week, parents can get their students registered the week of the 21st, and preschool can start on August 28th.

F. Business Report

- Asst. Supt. McKenzie is working on closing the 22-23 fiscal year.

A. Drinking Water Purification

Superintendent Baas provided info on the ozone/UV light purification system for the schools drinking water, and the possibility of switching to the use of chlorine.

B. Esports

Superintendent Bass presented info she learned at a 4-day training on Esports, including guidance about appropriate games for various grade levels, common concerns, statistics and research, and skills students can learn from playing video games. She discussed what an Esports program would look like at SV, including

students needing teachers to sign off on a weekly academic form in order to be able to participate.
