The Superintendent reported:

- The COVID outbreak appears to be over, with no new illnesses having been reported.
- The preschool is up and running and going well. In the next few months we should have a total of 11 students.
- Back to School Night was rescheduled for tomorrow night. The evening will begin with a parent meeting in the Annex followed by two 15 minute teacher sessions. The evening will finish at 7PM.
- Homework Hour started last week on Tuesday. It continues to be scheduled for Mondays, Tuesdays, and Wednesdays.
- A new speech pathologist, psychologist, and physical therapist are working with us through the SELPA.

B. Enrollment

47 students.

- Attendance rate for August was only 91% (12 school days).
- A COVID outbreak from Friday August 25th through Tuesday September 5th led to an absence rate as high 36%, with at least 10% of students out for 7 school days.
- There are currently 7 preschool students.

C. Curriculum and Instruction

- Esports price points were provided for Nintendo Switches, controllers, and games. The program will also include information such as online etiquette and careers in gaming. The next steps are to survey students and meet with parents. Student's teachers will have to give permission for them to participate.

D. Facility Update

- The official Preschool License has been received.
- The painting project has had a rocky start but things are going better now.

E. Business Report

The Asst. Supt. reported:

- Health Insurance rates for 2024 are increasing by 7.8% for United Healthcare and 13.2% for Kaiser.
- She will be attending three meetings on Friday, including countywide CBO and Small District CBO meetings and a SELPA joint operations/CBO meeting.
