IV. REPORT SECTION - Oral

A. Superintendent/Principal Report

The Superintendent reported:

The annual Winter Show is tomorrow night at 6 PM.

- Kelly Ford, the new Shakespeare director, was in this week doing auditions with students. The cast list will be posted on Friday so that students will be able to practice their lines over the break. Rehearsals will begin the week of January 8th.
- On Tuesday, Jon Moffat from Cyber Education Consulting presented to students in grades 2-8 about internet safety and social media, including texting. He was very engaging and also created a link to a parent video. The link was shared with families today through email and on Facebook. The video is only available for 30 days. SVEA paid for Jon to come out to present to our students and provide the parent video. We thank them for their willingness to pay for this.
- Spencer Valley is looking to join SDQPI which is another source to help us with preschool funding. As part of their consortium SV will receive money to purchase items for the classrooms and playground. This is a very in-depth program with many moving parts that will require time worked outside of regular work hours. As such, the District is looking at establishing a SDQPI Coordinator stipend. Gabby Farr has agreed to take this on outside her regular work hours.

B. Enrollment

- K-8 enrollment of forty-nine (49) students. Two students were added one in Kindergarten and one in 6th grade.
- Attendance rate for November was 93.6%; YTD attendance rate through November is 93.4%.
- Twenty-five (25) students had perfect attendance in October.
- Preschool enrollment of twelve (12) students, only 2 are full time.

C. Curriculum and Instruction

- The Superintendent is working with SDCOE on health curriculum.
- Cursive must be added to the instructional day for 1st through 6th grades. Curriculum is being explored.

D. Facility Update

- Supt. Baas and Asst. Supt. McKenzie have created a list to prioritize facilities needs. The list currently includes a generator for the well pump (requirement as of January 1, 2024), a new tank for the well, walkie talkies that work in the annex, interior painting, and irrigation.

E. Business Report

- Information was shared about the Classified School Employee Summer Assistance Program which allows 10- and 11-month classified employees to withhold income from monthly paychecks, receiving the income back in the summer months they do not work, with a match from the state.
